## Eligibility to apply:

- Candidates who have a Post Graduate Medical / Dental degree (DM / MCH / MD / MS / DNB / MDS) from Medical College / Institution recognized by NMC / MCI / DCI with A.P State Medical / Dental Council Registration and aged below 44 years as on date of appointment.
- 2. Non-Local candidates with AP Medical / Dental Council Registration are eligible for Senior Residency if local candidates are not available.

(NOTE: Local Candidature: - A candidate studied at least 4 years from 4th to 10th in AP. In case of study of 4th to 10th in Telangana and migrated to AP after bifurcation, then certificate from the revenue authorities to that effect as per G.O.Ms.No.132 & 133 GA (SPF&MC) Dept. 13.06.2016 (proof of local candidate).

### **Documents to be verified:**

- 1. S.S.C. certificate (proof of date of birth)
- 2. Marks lists of Post-graduation (MD / MS / Mch / DM / MDS /DNB.
- 3. Copy of Degree/ Provisional Degree Certificates of MBBS, Post-graduation MD / MS / MDS / DNB and Super Specialty DM/M.Ch/DNB
- 4. Registration of PG / Super-specialty degree with A.P. Medical Council.

6. Study Certificate from 4th to 10th Class. In case of study of 4th to 10th in Telangana and migrated to AP after bifurcation, then certificate from the revenue authorities to that effect as per G.O.Ms.No.132 & 133 GA (SPF&MC) Dept. 13.06.2016 (proof of local candidate)

#### **Selection Process:**

- 1. The merit scored in Post Graduation exam (including theory & practical) will be the criteria for preparing merit list.
- 2. Rule of Reservation (RoR) at institution level shall be followed.
- 3. In any SR posts are vacant after applying the RoR they have to be filled on Merit as these posts are tenure posts.
- 4. Local candidates who completed Post Graduation in recently conducted regular examinations by Dr. YSRUHS in Andhra Pradesh Medical/Dental colleges has to be given first priority. Local candidates who completed Post Graduation in other states will be given second priority. Non-Local candidates will be given third priority.
- 5. In case of more than one candidate is having the same marks, Date of Birth will be taken into consideration and elder person will be given first preference.
